- Valid passport with at least 6 month validity from the date of travel.
- 1 Applicantion Form.
- 2 Photograph (Fresh ones i.e. NOT used earlier for any visa) 35 x 45 MM with white background.
- Certificate of Business Registration of Korean Company is required except for where inviter is a Korean Govt or public institution/organisation, <u>(Note: in case the inviter is an individual, employee certificate is needed)</u>.
- ITR 3 year returns
- Occupation proof
- In case of Employee Typed Employment Certificate on company letter head (Please find attached the Specimen in Form Section).
- In case applicant is the proprietor / owner of the company-: Photocopy of Business Registration Certificate, company memo, partnership deal, establishment license or proprietorship etc are required.
- If the applicant is sponsored proof of sponsorship
- If the applicant is retired- Proof of retirement, pension statements for the last three months; proof of regular income generated by ownership of property or business.
- Declaration Form (For Express Applications ONLY) to be signed by the applicant.

- Hotel Booking
- Tour Itinerary
